### Duties of Technical Delegates

- To ensure Events are conducted in accordance with the Rules; See Eventing rules Article 515.3
- To provide appropriate help and guidance;
- To inspect and approve the cross-country and jumping courses before they are shown to the riders; To authorise appropriate alterations being made if, in his/her opinion, these courses are not in all respects within the limits laid down in the Rules or are unsuitable for the classes of horses expected to take part;
- To submit a report to Equestrian Australia State Branch within 21 days of the event; May not perform any other role at an Official Event.
