Governing Rules

- This event is held under PCAWA Eventing Rules February 2015 in conjunction with Equestrian Australia's most current National Eventing rules. Entries for this event constitutes implicit acceptance of all PCAWA Eventing Rules 2015. <http://www.pcawa.com/eventing>
- Riders entered in Pony Club classes must be current financial members of a Pony Club affiliated with PCAWA.
- Open Class Riders must be over 18 years & must provide proof of insurance when entering an open class at a Pony Club event.
- All riders to provide a helper, job preferences considered but not guaranteed. No self-help on the weekend. Self-help only prior to event – Busy bees and set up. Please contact Event co-ordinator.
- PCAWA member cards must be shown to collect back number. Back Numbers to be worn in all phases. Riders must provide their own number holder and bridle number.

- Medical armbands and Back Protector are **COMPULSORY** for all grades and must be worn in cross country phase.
- PCAWA members competing in PCAWA classes must wear full Pony Club uniform for all phases.
- Riders must be a minimum of 9 years of age as of 1st January, 2015.
- No rider under 18 years is to be left on the grounds without a parent/guardian.
- Horses must be a minimum of 4 years of age.
- Riders are restricted to two rides in any PCAWA One Day Event.
- No one is allowed to ride the cross country course at the completion of the event.
- The use of insulting or abusive language by either a competitor or their parent or connections to any other competitor or official **WILL entail disqualification**
- **Withdrawals** can be made by the competitor via K-Trials online system up until closing. Refunds after event entry has closed will be given at the discretion of organisers only if a vet or doctor's certificate is supplied and if allocated helper job is carried out. A \$20 administration fee will apply. Failure to complete helper duty will result in a \$50 fee.
- "***Substitutions are permitted accompanied by a Veterinary Certificate. Mounts may be substituted before the commencement of the event upon presentation of a Veterinary Certificate. If such a substitution is made, the replacement mount must be eligible within the terms of the PCAWA Rules. No substitution of rider is permitted under any circumstances***"

No dogs are allowed on the grounds.
