

CONDITIONS OF ENTRY – RULES AND REGULATIONS

- 1. All horses must be registered with the PHAA and all owners, riders, handlers and youth must be financial members of the Paint Horse Association of Australia to show, ride or exhibit at the State Championships.
- 2. Photocopies of current Paint Horse Association of Australia Amateur and Youth Cards and Registration of horses to be sent with entries. Amateur cards must be available for inspection at the show if requested.
- 3. No pending registration horses.
- 4. Foals must be a minimum of 18 weeks of age before they are allowed to be shown. No foal born after 25 October 2014 is allowed to be shown.
- 5. No competitor or representative of a competitor may enter the ring and speak directly to the judge. All enquiries and protests should be addressed to the Show Secretary.
- 6. Disputes Committee: Written protests to be received an hour after the incident with a deposit of \$50.00 which will be forfeited to the Association if protest is dismissed.
- 7. All halter and performance classes will be run under the Rules of the HSAA and PHAA. This show runs under the HSAA and PHAA **Animal Welfare Policy** and is applicable to all Horses, Handlers and Competitors. Any incidents MUST BE reported to the Show Secretary on the day of the show.
- 8. There will be no substitution of horses or riders on the day from the horses/riders entered and no substitution of horses/rider from one event to another.
- 9. Competitors for each class will be called to enter the marshalling area and no late entries are permitted into the ring. Classes will not be held up for late arrivals, please ensure that if you are showing more than one horse you are ready when called for.
- 10. The Organising Committee will not be responsible for injury, death or loss to any person (competitor or spectator), livestock or property that may occur during the course of the show, whether attributable to the negligence of the Organiser or not.
- 11. The Show Committee reserves the right to alter or amend this programme if required.

INDEMNITY, RELEASE & WAIVER OF LIABILITY

I understand, acknowledge and accept that my attendance at these grounds and in the precincts of this event is undertaken on the following basis:

I understand and acknowledge that all aspects of handling, working with and in the vicinity of riding horses/hand held horses, is a dangerous activity and that horses can act in a sudden and unpredictable (changeable) way at any time.

I understand and acknowledge that serious injury or death may result from all activities involving horses.

I agree that I compete and /or attend any show/clinics conducted or authorized by Statewide Paint Horse Association of WA Inc at my own risk and that I save harmless the Statewide Paint Horse Association of WA Inc and /or any management appointed or authorized by Statewide Paint Horse Association of WA Inc and I shall not pursue the Statewide Paint Horse Association of WA Inc and hold them liable for any personal injury, death, loss or damage occasioned to me or my spouse, children, employees, strappers or assistants or any person attending the show on my behalf or at my bequest or for loss of damage occasioned to any of my possessions or horses whether such liability arises out of any express or implied term of law whether at common low or by statute, or through negligence of any member of Statewide Paint Horse Association of WA Inc or any management appointed or authorized by the Statewide Paint Horse Association of WA Inc arising in any manner whatsoever and I fully indemnify and save harmless Statewide Paint Horse Association of WA Inc and/or any management appointed or authorized by Statewide Paint Horse Association of WA Inc against such claim whatsoever such may arise.

My attendance and /or participation in this event is acknowledgement of my acceptance of its terms as a condition precedent to my competing at this event and I acknowledge that such may be the pleaded by the Statewide Paint Horse Association of WA Inc and/or any management appointed or authorized by the Statewide Paint Horse Association of WA Inc as a bar to any claim made or action taken by me.
