Board acknowledged jumping committee stepping down, caused concern and confusion with members. Voting rights were not clear with members as to what they had to initiate to have a right to vote. Board to look at the constitution for possible review. All constitutions were to comply by 1<sup>st</sup> July with the Incorporations Act. EWA has been compliant from 2018. Kevin Gianatti requests board to seek legal advice on actions taken to dismiss previous committee and if can be reinstate. Also wants board to acknowledge social media negativity to jumping members.
