Rules

This event will be conducted under pony club rules, entering this event constitutes implicit acceptance of the PCAWA rules. All competitors are ultimately responsible for knowing these rules and complying with them. All entrants must show evidence of PCAWA or EA membership.

Safety & wellbeing of riders & horses is paramount, no dangerous riding will be accepted, riders are to treat their mounts in a kind & encouraging manner.

If 3 refusals are incurred at any one obstacle, competitors may proceed to the next obstacle.

All riders suffering a fall must immediately report to first aid, and gain a clearance prior to resuming riding.

Dressage

A marked test will be provided as feedback, however the test will not be totaled with a %. There is no elimination in dressage. If your horse steps out of the ring you are able to recommence etc.

Withdrawals / Refunds

Please notify the organizer if you are withdrawing, refunds will only be given upon submitting vet or doctors certificate.

Clean up

All entrants must clean up after themselves & horses prior to leaving the grounds.

Vet

A vet will not be at the event, however closest vet is Baldivis Vet Clinic. Substitute mounts will be accepted providing a vet certificate is provided prior to start of event.

First Aid

There will be a first aid post for the day. Ambulance will only be called in, as required. Riders, Parents / guardians will be responsible for any cost incurred by calling an ambulance, or subsequent medical treatment. No mid competition Substitution of Riders is accepted under any circumstances.

NO DOGS ALLOWED

Competitors please note:

- PCAWA Gear checking rules apply. Long sleeves must be worn & being sunsmart is encouraged.
- All riders must be financial members of a Pony Club and show their insurance card.
- All competing horses must be four (4) years of age or more for SJ. Dressage minimum rising 4yrs.
- No rider under 18 years of age is to be left on the pony club grounds without a parent or guardian.
- Lead line & First ridden may enter in appropriate classes eg: Prep Dressage & 30cm SJ
- Mounts which in the opinion of the club representative or their nominee are considered unsafe or unsuitable can be prevented from competing at this event.
- Mounts (refer – rules for Pony Clubs affiliated with PCAWA) No Stallions, colts and rigs.
- It is not compulsory to complete 2 rounds of both disciplines (up to riders / leaders discretion), if riders choose to not compete in any phase please let the marshall know, this does not constitute a refund.
