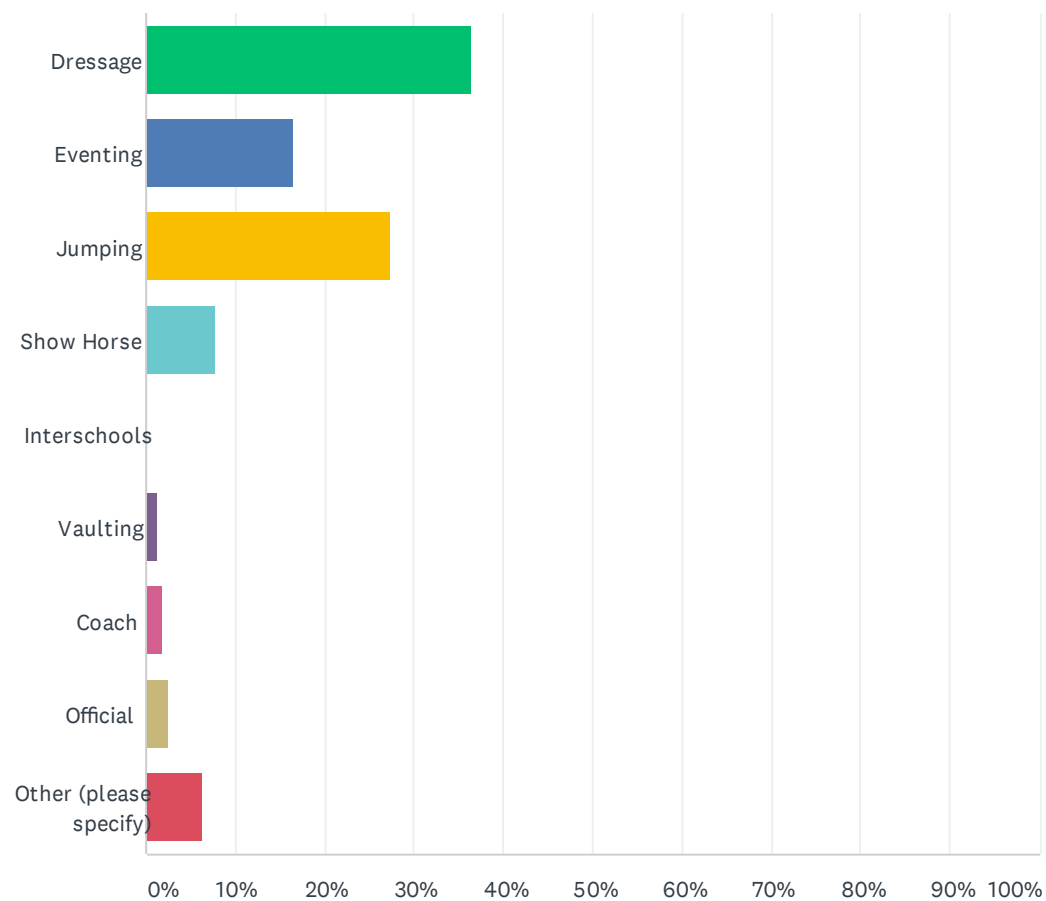


Q3 What is your principle Equestrian Australia discipline (please choose ONE only)

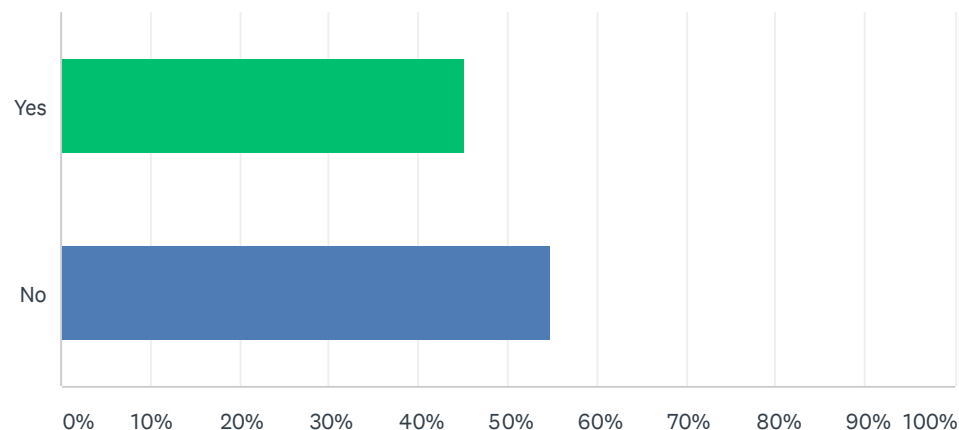

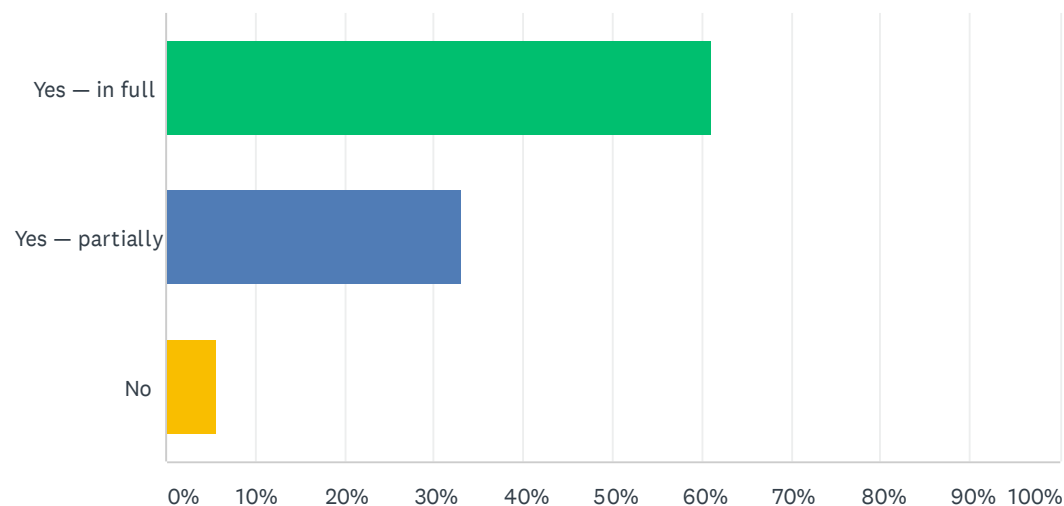

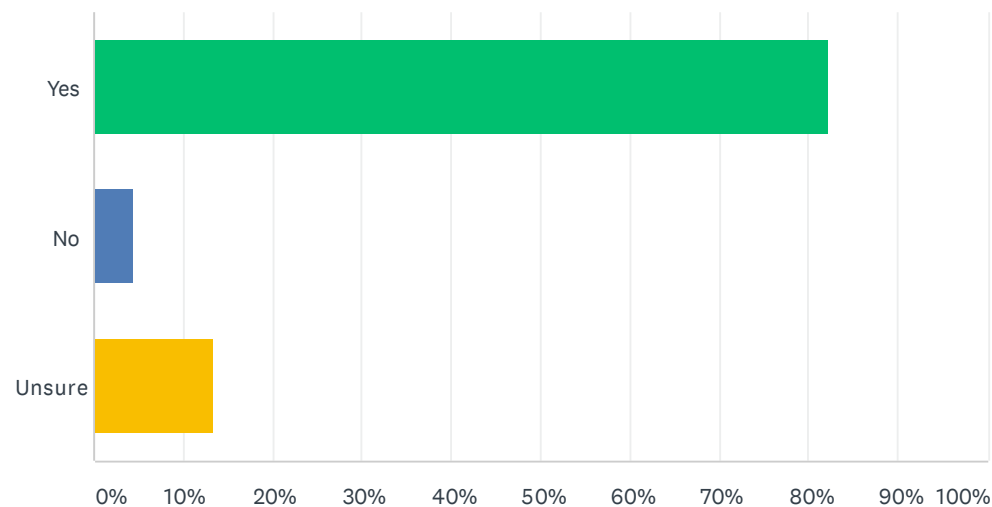

Q6 Do you support the undertaking of a comprehensive governance review aimed at achieving governance reform in equestrian sport?

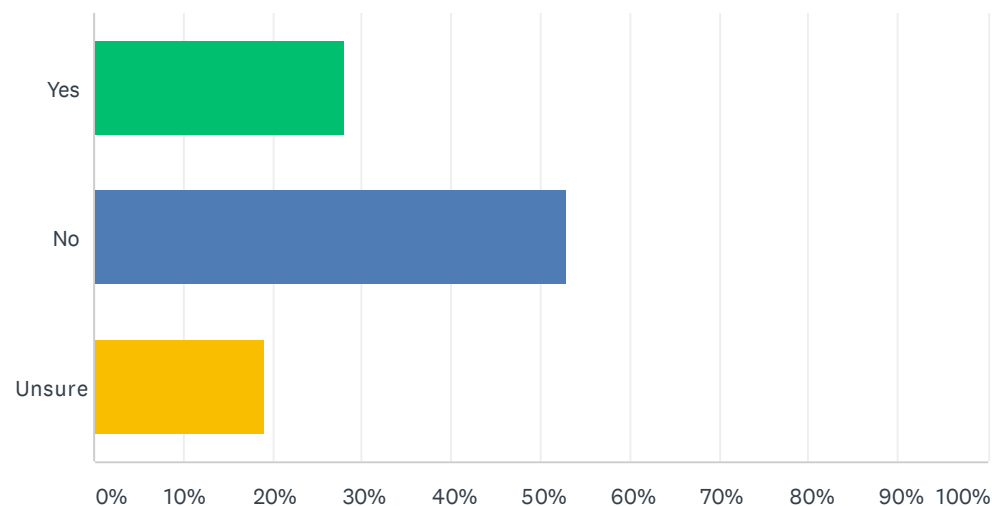

Q7 Do you wish KordaMentha to have sole decision making in selecting the interim EA Board?

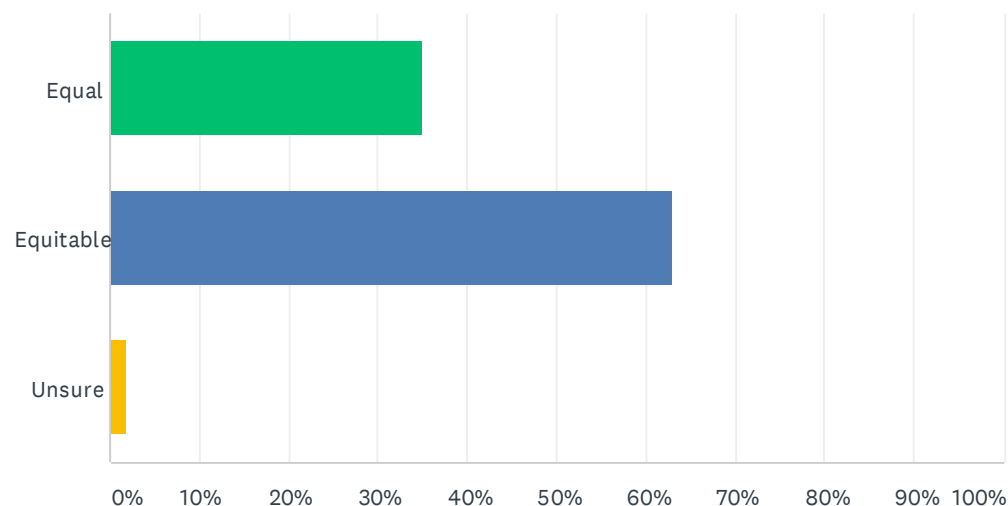

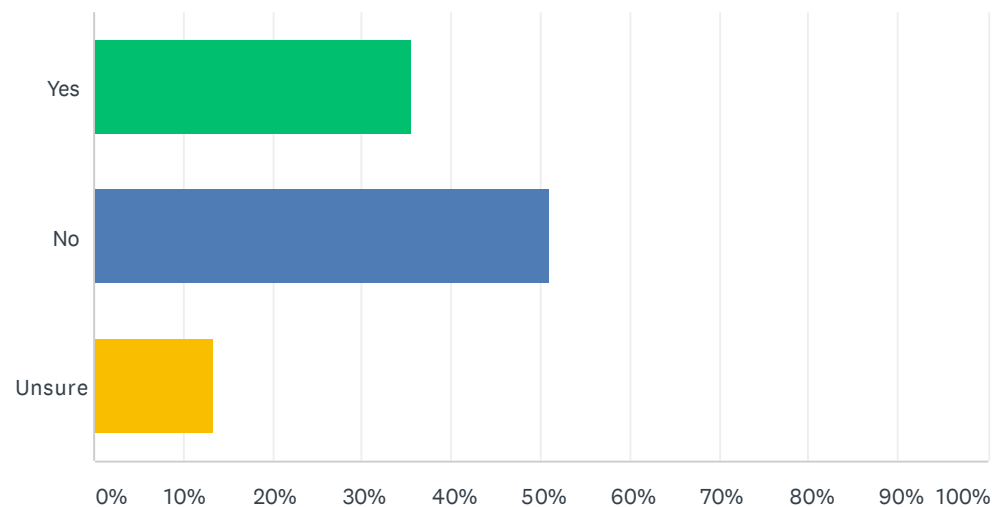

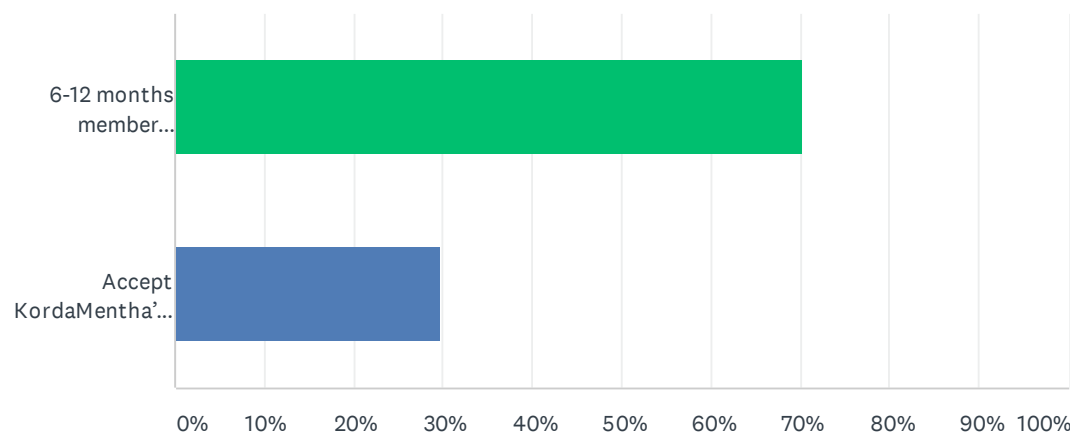

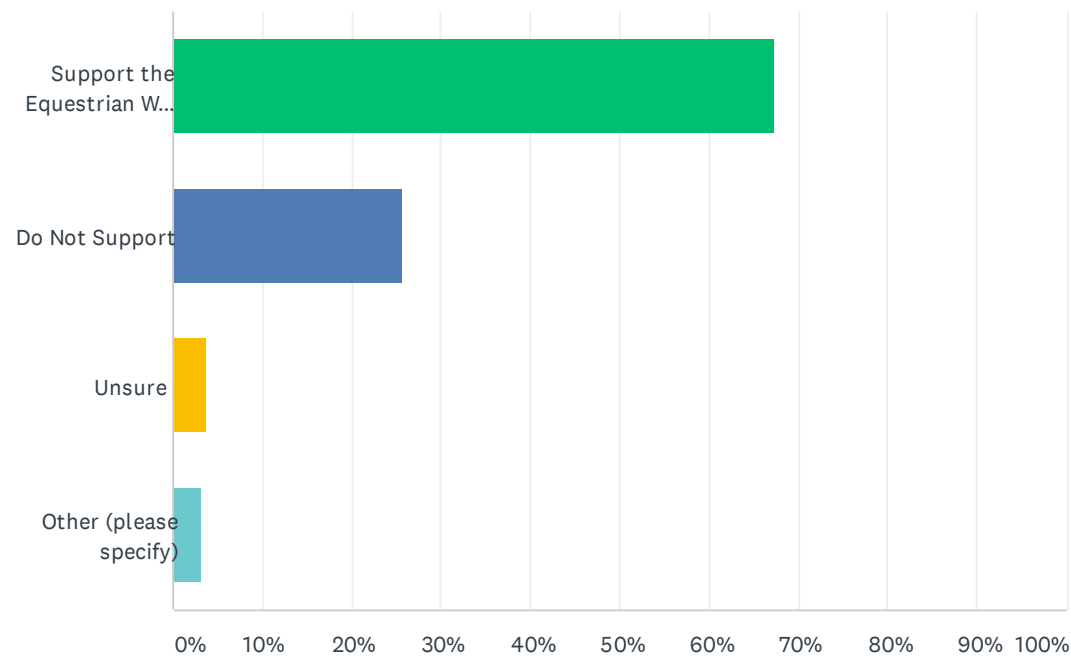
