Recommendation to Board from Audit and Risk committee:

The committee has reviewed EWA's position from an organisational and financial perspective and has made recommendations to the board regarding the SEC operations and EWA finances.

GE concerned about making a decision as the new cashflow varies from the previous document. Not willing to proceed to vote due to short notice of viewing document. Resolved that GE/RoH/CEO to work together to review cashflow.

RoH stated the importance to speak to CoS/DSR re 30 June lease deadline to discuss what the future looks like, possible support and best way forward with lease.

Discussion re board consultation and clear reporting re SEC concept plan. RF left meeting at 7.04pm

AD - Concept Plan has many hurdles and the financial concerns need to be addressed.

GE said there are many options available to find cash. CEO said EWA staff reductions will impact members.

AW - not keen to spend more on reports. GE to present scope to Board before proceeding. AD - next reports should be considerably more. GE said other stakeholder would be asked to contribute.

RoH - we need to communicate to members at AGM with options re SEC.
