Update report from SEC committee re Concept Plan progress:

• Meeting with City of Swan postponed to Monday 23 May at 1pm, with new CEO to attend.

SEC Lease/Insurance and Fire services:

- I. City of Swan lease extension documentation renewal, CEO to follow up with council of status.
- 2. Insurance due end of June, dependant on Fire Services grant being actioned.

Arena tender update:

It was unanimously agreed by the board to approve works subject to costs and negotiated T&C's and funding from DLGSC.

Special Olympics:

AD updated the board on discussions with Tanya Brown (board of Special Olympics Australia Committee - SOAC) about the inclusion of EWA/SEC if Perth was successful.

AD informed the board that:

- Perth was putting in a bid for 2027; the biggest event of the year, twice the size of the Paralympics.
- The location would be finalised in November, however Perth is favourite.
- The SOAC have earmarked SEC as a preferred venue of choice to hold events. A meeting is being held Thursday to discuss venues.
- The idea to create a 'hub' in the Swan Valley golf at Vines, etc
- Use the Special Olympic Games as a major catalyst for inclusion and way to get funding through to the SEC as a new source of income.

- Strategy review held online May 4, roughly 50 people attended.
