Confirmation of Minutes of Board meeting on 29th September 2020

General Business

Equestrian Australia

RF reported

New EA Board announced with EWA member and EWA Jumping committee Chair Lucy Galovicova appointed to the EA Board as a Director.

RF to write to EA Board stating EWA is looking forward to EA review and our participation.

EWA had written to EA and EA administrators re EA Coaching that their Charter is being changed without an EA Board or a review process in place. EWA Coaching also has concerns. CEO raised this with the support of other CEOs' to the EA CEO, we were informed that this was an operational issue for EA to administer Coaching as they see fit. EWA has not received a response, CEO to follow up.

EWA Audit and AGM

AGM attended by 34 members, meeting was well attended with some question raised, these were answered by Chair/ Finance director and CEO.

RF and CEO presented information session on SEC Business model review, discussion on the SEC followed as outline in AGM minutes

WNW thanked RF/ROH/CEO for answering all questions and noted the high quality of questions from members

Annual elections

Notice of EWA annual elections has been sent to all members on Monday 2nd November, with voting to open Tuesday 3rd November and voting closing 30th November. Election will be conducted online by Nominate.

EWA tax consultant has been appointed scrutineer

CEO has contacted all Sport committees outlining the process for committee Appointed and Coopted positions. RF and CEO to meeting with each of the Sport committees and their elected members to discuss committee governance.

Lotterywest Resilience grant

Lotterywest grant of \$300,000 has been placed in separate EWA account.

Sport committees have been informed of grant allocations to each sport committee and the acquittal requirements.

The DSR FAA 18/19 repurposed grant of \$420,000 has been drawn down to \$138,060 from 1 July 2019 to 23 August 2020, this does include the full payment of insurance until June 30th 2021. DSR have been supplied with acquittal information up to end August. Still waiting sign off

Proposed SEC restructure and funding review:

- SEC City of Swan dust suppression grant, EWA waiting for grant contact.
- 12 month SEC lease extension 31st December 2021 with the same terms maintained. Approved by COS 14/09/20.
- COS to received EWA SEC Business model proposal outline.
- EWA/DSR review SEC asset management plan and priorities needed to maintain the SEC fit of purpose and supply copy to COS. Being finalised
- COS/DSR to work together to identify funding options including ownership options.
- EWA to supplied information on our preferred option and governance structure to DSR
- COS to visit site 30/09 to confirm all buildings and areas are correctly identified. Site visit completed, COS compiling new plan
- COS officers require to submit their SEC proposal to council before December. EWA to submit funding request in time for COS budget
- EWA Board proposed SEC management options and preferred model presented to: Present at AGM (6/10) completed Hold meeting with SEC sub tenants/home based clubs and Eventing clubs 20/10 completed
