### **Conditions of Entry**

- 1. The event will be held in accordance with the current EA dressage rules (as amended). All competitors please be familiar with rules as the organizing committee will make no exceptions.
- 2. An Equestrian Competition Hendra Biosecurity Checklist has been completed for this event. Any horse entered that has resided, visited or returned from an Endemic Region (as defined by EA Hendra Vaccination By-law annexure 3)must be Hendra Vaccinated and a Hendra Vaccination Certificate is to be presented for the entry to be valid. Please refer to www.equestrian.org.au for more information.

3. An EA disclaimer must be signed and submitted (via Nominate or email) or entry will not be accepted. The organizing committee reserves the right to alter or amend the program or refuse entry. Entries will be accepted on a first come first served basis. However The organizing committee reserves the right to close classes when: Participation—class allocation is full.

Competitive— if there is an oversubscription of entries for class allocation, a ballot system will be adopted.

- 4. Callers are not permitted
- 5. Arena surface is woodchip and warm-up arena a mix of woodchip and sand. Please see www.svep.cavalletti.com.au/facilities.html for further details
- 6. Pony and Horse Competitions will be run with one arena with the second used for warm-up for the next three horses in the class. Participant riders will have two arenas run concurrently and will need to follow the marshall's instructions for entry to arena's. Warm-up area at rear of clubrooms will have a marshall directing the next rider to the competition arena.
- 7. Canteen food will be available on both days of competition with tea, coffee, drinks and cakes available for purchase.
- 8. Limited yards available on the day– Stallions will take preference. Please ensure you clean up manure and hay when you leave.
- 9. If parking near arena please be mindful of competitors riding when loading and unloading horses. Please refer to SVEP Parking rules at the end of this schedule.
- 10. Sashes will be allocated for 1st to 3rd place getters in each class for 5 starters or less and 1st to 6th place for up to 15 starters.
- 11. A prize and rosette will be awarded to both the highest percentage Junior rider and Young rider for the Competitive Pony and Competitive Horse competitions only. To be eligible you must have nominated as either a junior or young rider on the entry form. For the purpose of this Competition -

<u>Juniors</u> are defined as those riders aged on the day of the Competition, between 10 (in ponies) or 12 (in horses) to 15 years old. Young Riders are aged from 16 to 21 years on the day of Competition.

12. Prize Money to be allocated :

- 13. Hygain sponsored rug will be presented to the Swan Valley Dressage Association member who achieves the highest percentage in any class. In the event there is a tie then a decision will be made by referring to the collective marks. This rug will be presented at our AGM in November.
- 14. Entry is via Nominate website www.nominate.com.au—no exceptions
- 15. As per the Australian Dressage Rules a refund may only be made if documented proof (i.e. veterinary or medical certificate) is produced within 24 hours of the completion of the event to the event secretary. Where this is the case at least 50% of the entry fee will be refunded.
- 16. Neither the Organising Committee, Swan Valley Dressage Association to which these rules apply nor the EA accepts any liability for any accident, damage, injury or illness to horses, owners, riders, grounds, spectators or any other person or property whatsoever.
- 17. Entrants must adhere to the EA Codes of Conduct.

#### Swan Valley Equestrian Park Rules

#### **Float Parking**

Floats MUST be parked at an angle alongside the arena. This means you MUST drive down around the statue near the clubhouse before returning to a spot and parking with your nose in as close as possible. This way there is more room for everyone and it is safer. Please also make sure you leave sufficient room between your vehicle and the next. This procedure is clearly outlined on the diagram (see right).

There is also space for overflow floats near the day yards.

Spectators' cars must not be parked in the float parking areas -please park alongside the clubhouse, near "Rusty" the big horse statue. This is a requirement of our insurance.

#### Yards

There are limited yards available. Stallions will have precedence over other horses.

Strictly no portable yards to be set up as per SVEP rules

#### Horse Manure

Please make sure you clean up after yourself and your horses. This means picking up as much stray hay as possible and, most importantly, clearing up ALL manure and other rubbish. If your horse has dug a hole, please ensure it has been filled in before you leave.

#### Please No Dogs

Much as we love our dogs, please do not bring your dog to the SVEP. This is a SVEP requirement. You will be politely asked to leave. This includes leaving dogs in cars, which is not allowed.
